

## **Official Facebook Giveaway Rules & Regulations**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This contest is open to active Facebook profiles for individuals who reside in Saskatchewan, Alberta, or Manitoba.
2. **Agreement to Rules:** By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of St. John Bosco Wilderness Camp as final and binding as it relates to the content of this contest.
3. **Contest Period:** Entries will be accepted online starting April 7, 2024 on and ending April 11, 2024. All online entries must be received by 11:59PM Saskatchewan time on April 11, 2024.
4. **How to Enter:** The contest must be entered by liking, commenting on, and/or sharing our post. You may enter only once. The entry must fulfill all contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of St. John Bosco Wilderness Camp.
5. **Prizes:** The one (1) Winner of the contest (the “Winner”) will receive two (2) tickets to the Northern Call Fundraising Gala hosted at Marquis Hall Event Centre in Saskatoon, SK on April 20, 2024. Value of \$200. The specifics of the prize shall be solely determined by St. John Bosco Wilderness Camp. No cash or other prize substitution shall be permitted except at St. John Bosco Wilderness Camp’s discretion. The prize may be transferred to another person upon request from Winner at the discretion of St. John Bosco Wilderness Camp. Any and all prize-related expenses, including without limitation any and all federal, provincial, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for St. John Bosco Wilderness Camp to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

St. John Bosco Wilderness Camp shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 24 hours from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected.
